1. K.I. Singh Rural Municipality Office & MOFAGA(Ministry of federal Affairs and General Administration) **has allocated funds** from **GoN** towards the cost of **Construction of Administrative Office Building** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of Administrative Office Building(12/KISRMUN/2078-079)**. Bidding is open to all eligible as per Section V of bidding document.
2. K.I. Singh Rural Municipality invites electronic bids from eligible bidders for the construction of **Administrative Office Building** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:[**Nrs. 51,200,000/- (Fifty One Million Two Hundred Thousand)]**
 - Minimum Work experience of similar size and nature: **[One (1) Contract of RCC Framed Building Construction Project within the last Five (5) years with a value of at least Nrs. 70,000,000/- (Seventy Million)Including VAT]**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Electronic bids must be submitted to the office KI Singh Rural Municipality Office Wayal, Doti through PPMO's e-GP system www.bolpatra.gov.np/egpon or before 12:00 Noon on Jun 10-2022 (2079/02/27).. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on Jun 10-2022 (2079/02/27)at the office of KI Singh Rural Municipality Office Wayal, Doti. Bids must be valid for a period of 120 (One Hundred Twenty) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 20,90,000/- (Twenty Lakh Ninety thousands Only), which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
